**ACUERDO** del Subsecretario de Egresos de la Secretaría de Finanzas y Administración, que tiene por objeto establecer y dar a conocer la fórmula para la distribución a los Municipios del Estado de Puebla, de los recursos del Fondo de Fiscalización y Recaudación de la Entidad Federativa, correspondientes al Ejercicio Fiscal 2014, a que se refiere el artículo 4o. de la Ley de Coordinación Fiscal, así como los montos estimados a entregar a cada uno de los Municipios.

### CONSIDERANDO

Que el artículo 4o. de la Ley de Coordinación Fiscal vigente, establece que el Fondo de Fiscalización y Recaudación para las Entidades Federativas, se conforma con el 1.25% de la Recaudación Federal Participable de cada ejercicio, asimismo, prevé que los Municipios recibirán como mínimo el 20% de los recursos que del citado Fondo corresponda al Estado.

Que es obligación del Estado dar cumplimiento a lo previsto en el artículo 4o. de la Ley de Coordinación Fiscal, por lo que resulta necesario establecer y dar a conocer la fórmula para la distribución entre los Municipios de esta Entidad Federativa, del 20% de los recursos que les corresponden del Fondo de Fiscalización y Recaudación para el Estado Libre y Soberano de Puebla, la cual se basa en criterios de equidad para la distribución, con el objeto de combatir la pobreza y superar los rezagos sociales tanto rurales como urbanos, al tiempo de atacar los desequilibrios entre las distintas regiones, a través de la creación de condiciones adecuadas para la inversión productiva.

Que de acuerdo a las facultades que me confieren los artículos 4o. de la Ley de Coordinación Fiscal; 81 y 83 de la Constitución Política del Estado Libre y Soberano de Puebla; 14 párrafo primero, 17 fracción II, 19, 27 y 35 fracciones V, VII y LXXXIX de la Ley Orgánica de la Administración Pública del Estado de Puebla; 55 fracción I, 56, 57 y 59 de Ley de Coordinación Hacendaria del Estado de Puebla y sus Municipios; 3, 4 fracción V, 6 párrafos segundo y cuarto, 10 fracciones III, IV y XXXIII, así como 38 fracciones I, XX y XXI del Reglamento Interior de la Secretaría de Finanzas y Administración, he tenido a bien expedir el siguiente:

### ACUERDO

**PRIMERO.-** El presente Acuerdo tiene por objeto establecer y dar a conocer la fórmula para la distribución a los Municipios del Estado de Puebla, de los recursos del Fondo de Fiscalización y Recaudación de la Entidad Federativa correspondientes al Ejercicio Fiscal 2014, a que se refiere el artículo 4o. de la Ley de Coordinación Fiscal, así como los montos estimados a entregar a cada uno de los Municipios.

El monto estimado del Fondo de Fiscalización y Recaudación que percibirá el Estado de Puebla, de conformidad a lo dispuesto en el Acuerdo por el que se da a conocer a los Gobiernos de las Entidades Federativas la Distribución y Calendarización para la Ministración durante el Ejercicio Fiscal 2014, de los recursos correspondientes a los Ramos Generales 28 “Participaciones a Entidades Federativas y Municipios”, y 33 “Aportaciones Federales para Entidades Federativas y Municipios”, publicado en el Diario Oficial de la Federación de fecha 24 de diciembre de 2013, es por la cantidad de \$1,072’260,346.00 (Un Mil Setenta y Dos Millones Doscientos Sesenta Mil Trescientos Cuarenta y Seis Pesos 00/100 M.N.).

Del total de los recursos correspondientes al Estado de Puebla por el Fondo de Fiscalización y Recaudación, el 20% se distribuirá entre los Municipios de acuerdo a lo siguiente:

**I.** Un 40% se distribuirá considerando la recaudación del Impuesto Predial que capten los 217 Municipios y los cobros de servicio de agua potable que capten los mismos o sus Organismos Operadores, de acuerdo a los artículos 53 y 54 de la Ley de Coordinación Hacendaria del Estado de Puebla y sus Municipios.

**II.** Para la distribución de otro 40% a los Municipios se considera el mismo criterio del numeral I pero conformando 3 grupos de acuerdo a su participación en el total de la recaudación del Impuesto Predial y cobros de servicio de agua potable del ejercicio inmediato anterior, de acuerdo a lo siguiente:

- a) Grupo 1: Integrado por los Municipios con una recaudación mayor al 1% de la recaudación total.
- b) Grupo 2: Conformado por los Municipios con una recaudación del 0.10% al 1% de la recaudación total.
- c) Grupo 3: Integrado por los Municipios con una recaudación menor al 0.10% de la recaudación total.

**III.** El 20% con el fin de incentivar los esfuerzos para incrementar la recaudación, estableciendo un monto de compensación a los Municipios que como resultado de la distribución establecida en los numerales I y II reciban menos de \$10,000.00 (Diez Mil Pesos 00/100 M.N.) mensuales, y un monto de equidad conformado con los recursos remanentes después de asignar el monto de compensación distribuyendo éstos en partes iguales a los 217 Municipios.

$FOFIR$  es el monto del Fondo de Fiscalización y Recaudación que le corresponde al Estado.

### **CONSIDERANDO**

Que el artículo 4o.-A de la Ley de Coordinación Fiscal vigente, precisa que 9/11 de los recursos provenientes de la recaudación derivada de la aplicación de las cuotas previstas en el artículo 2o.-A fracción II de la Ley del Impuesto Especial Sobre Producción y Servicios, corresponderá a las Entidades Federativas en función del consumo efectuado en su territorio, de acuerdo con la información que Petróleos Mexicanos proporcione a la Secretaría de Hacienda y Crédito Público, complementada, en su caso, con la información del Servicio de Administración Tributaria, siempre y cuando se encuentren adheridas al Sistema Nacional de Coordinación Fiscal.

Que con fecha 31 de enero de 1997, fue publicado en el Periódico Oficial del Estado, el Convenio de Colaboración Administrativa en Materia Fiscal Federal celebrado entre el Gobierno Federal, por conducto de la Secretaría de Hacienda y Crédito Público y el Gobierno del Estado de Puebla.

Que el 5 de febrero de 2008, se publicó en el Diario Oficial de la Federación, el Anexo 17 al referido Convenio de Colaboración Administrativa, con el objeto de que el Estado ejerza las funciones operativas de administración, recaudación y cobro de los ingresos provenientes de la recaudación derivada de la aplicación de las cuotas previstas en el artículo 2o.-A fracción II de la Ley del Impuesto Especial Sobre Producción y Servicios.

Que el penúltimo párrafo del artículo 4o.-A de la Ley de Coordinación Fiscal, señala que los Municipios recibirán como mínimo el 20% de la recaudación que corresponda a la Entidad Federativa, así como que la distribución del porcentaje mencionado por parte de las Entidades Federativas a los Municipios, deberá realizarse cuando menos en un 70% atendiendo a los niveles de población.

Que es obligación del Estado, dar cumplimiento a lo previsto en el artículo 4o.-A de la Ley de Coordinación Fiscal, por lo que resulta necesario establecer y dar a conocer la fórmula para la distribución entre los Municipios de esta Entidad Federativa, del 20% de los 9/11 de los recursos provenientes de la recaudación derivada de la aplicación de las cuotas previstas en el artículo 2o.-A fracción II de la Ley del Impuesto Especial Sobre Producción y Servicios, en la cual el 70% se asignará atendiendo a los niveles de población, y el 30% restante bajo criterios que permitan aplicar recursos en proporción inversa a los niveles de población, con el objeto de combatir la pobreza y superar los rezagos sociales, tanto rurales como urbanos, al tiempo de atacar los desequilibrios entre las distintas regiones de la Entidad.

Que de acuerdo a las facultades que me confieren los artículos 4o.-A de la Ley de Coordinación Fiscal; 81 y 83 de la Constitución Política del Estado Libre y Soberano de Puebla; 14 párrafo primero, 17 fracción II, 19, 27 y 35 fracciones V, VII y LXXXIX de la Ley Orgánica de la Administración Pública del Estado de Puebla; 55 fracción II, 56, 57, 60 y 61 de la Ley de Coordinación Hacendaria del Estado de Puebla y sus Municipios; 3, 4 fracción V, 6 párrafos segundo y cuarto, 10 fracciones III, IV y XXXIII, así como 38 fracciones I, XX y XXI del Reglamento Interior de la Secretaría de Finanzas y Administración, he tenido a bien expedir el siguiente:

## ACUERDO

**PRIMERO.-** El presente Acuerdo tiene por objeto establecer y dar a conocer la fórmula para la distribución a los Municipios del Estado de Puebla, de los recursos provenientes de la recaudación derivada de la aplicación de las cuotas previstas en el artículo 2o.-A fracción II de la Ley del Impuesto Especial Sobre Producción y Servicios, correspondientes al Ejercicio Fiscal 2014, de conformidad con el artículo 4o.-A de la Ley de Coordinación Fiscal, así como los montos estimados a entregar a cada uno de los Municipios.

El monto estimado de los Incentivos por el Impuesto a la Venta Final de Gasolinas y Diesel que percibirá el Estado de Puebla, de conformidad a lo dispuesto en el Acuerdo por el que se da a conocer a los Gobiernos de las Entidades Federativas la Distribución y Calendarización para la Ministración durante el Ejercicio Fiscal 2014, de los Recursos Correspondientes a los Ramos Generales 28 “Participaciones a Entidades Federativas y Municipios”, y 33 “Aportaciones Federales para Entidades Federativas y Municipios”, publicado en el Diario Oficial de la Federación de fecha 24 de diciembre de 2013, es por la cantidad de \$649’571,986 (Seiscientos Cuarenta y Nueve Millones Quinientos Setenta y Un Mil Novecientos Ochenta y Seis Pesos 00/100 M.N.).

Del total de los recursos correspondientes al Estado de Puebla, provenientes de la recaudación derivada de la aplicación de las cuotas previstas en el artículo 2o.-A fracción II de la Ley del Impuesto Especial Sobre Producción y Servicios, el 20% se distribuirá entre los Municipios conforme a lo siguiente:

**SEGUNDO.-** El Fondo a que se refiere este Acuerdo se distribuirá por parte del Estado, en forma mensual a los Municipios, en el mismo día en que se realice la entrega inmediata siguiente de las participaciones que les correspondan a los Municipios, asimismo, los montos entregados se publicarán en el Periódico Oficial del Gobierno del Estado, en la siguiente fecha de la publicación a que se refiere el penúltimo párrafo del artículo 6o. de la Ley de Coordinación Fiscal.

**TERCERO.-** La Secretaría de Finanzas y Administración, realizará la distribución de los recursos financieros que perciba, de conformidad a lo dispuesto por el artículo 4o.-A de la Ley de Coordinación Fiscal y demás disposiciones aplicables.

### DISPOSICIÓN TRANSITORIA
